Terms & Conditions:

1. The promoter is: Sunshine Coast Credit Union (SCCU)
2. Employees and contractors of the promoter, and its subsidiaries, or helping to set up the competition shall not be permitted to enter the competition.
3. There are two separate contests: one for Facebook and one for Instagram. Rules of the competition are as follows:

FACEBOOK:

Each contestant can enter the contest by:

- 1) Follow SCCU on Facebook and like SCCU's #Loyal2LocalChallenge post
- 2) Take a picture of a purchase from your favorite local Sunshine Coast business (or a picture of the business itself)
- 3) Post the picture in the comment section of SCCU's Facebook #Loyal2LocalChallenge post and tag the local business you are supporting.
- 4) Bonus entry: Share to your own Facebook page, tag us @sunshinecoastcreditunion, and use #loyal2localchallenge. Privacy settings on the post must be made public or we will not be able to view post and contestant will be not be eligible for draw for bonus entry.

Each contestant may only enter the competition once. Multiple comments will only count as a single entry.

Contestants must be at least 19 years of age.

INSTAGRAM:

Each contestant can enter the contest by completing all the following:

- 1) Follow us on Instagram and like SCCU's #Loyal2LocalChallenge post
- 2) Tag your friends (each friend is a separate entry)
- 3) Take a picture of a purchase from your favorite local Sunshine Coast business (or a picture of the business itself)
- 4) Post the picture on your own Instagram post or in your stories, tagging @sunshineccu and using #Loyal2LocalChallenge don't forget to tag the local business you are supporting!

Each contestant may only enter the competition once per week.

Contestants must be at least 19 years of age.
